SERVICES PROVIDED

Trinity Lutheran School is committed to offering your child activities and experiences which are developmentally appropriate and which promote positive growth and well-being in the areas of spiritual, social, academic, emotional, physical, creative, and intellectual development.

School Setting: Parent(s)/Guardian enroll the student in the school with the understanding that the school's curriculum requires student participation in religious services and includes religious training according to the precepts and doctrines of Trinity Lutheran Church, and the Wisconsin Evangelical Lutheran Synod (WELS).

- Parent(s)/Guardian agree that the student will take part in these services and the Christian educational instruction provided by the school, and will cooperate with the teachers and staff of the school providing these services and instruction.
- Parent(s)/Guardian who are not affiliated with the WELS understand that they are required to partake in a successful completion of Christian education instruction with Pastor as a condition of continued enrollment.
- Parent(s)/Guardian will cooperate in every possible way with the teachers and staff at Trinity Lutheran School.
- Parent(s)/Guardian will receive a copy of the Trinity Lutheran School Handbook and have an opportunity to discuss the school's philosophy with regard to Christian education before enrolling the student.
- Parent(s)/Guardian agree that the student will be subject to all rules and regulations set forth in the handbook and as otherwise established from time to time by the School Board of Trinity Lutheran School.
- Parent(s)/Guardian agree that the education process extends beyond any given school day and that the parent(s)/guardian will work with the student to encourage behavior and attitudes consistent with the policies of the school and the instruction in Christian education at all times.

Tuition and other fees: Parent(s)/Guardian understand that the normal annual charges are due and payable as shown below and agree that these amounts will be paid.

The School Board does understand that sometimes unexpected expenses arise which cause financial difficulties. If for some reason you cannot make the full payment or the monthly payments, please let the School Board Chairman know via face to face visit, phone call or email. Your child's Christian education is important to us, and the School Board is willing to work with you.

Parent(s)/Guardian understand tuition is due in advance on the first day of the month, and that failure to make timely tuition payments constitutes grounds for dismissal or withholding of my child's student records, or both. Parent(s)/Guardian understand that the school may charge a \$10 late penalty fee for tuition payments that are not paid within 15 days of the payment due date.

Parent(s)/Guardian understand that report cards will be withheld until all accounts are current, and that a student may be dis-enrolled for failure to keep financial accounts current.

Grades K-8:

- Families with more than two children in K-8 will only be charged for the first two children with additional children being free.

Preschool:

- Preschool tuition fees do not count towards the maximum cap. For instance, Trinity members with two children in K-8 and one in 5 day preschool would owe \$2,987.25 in tuition fees.
